Since our inception in 1972, Tri-County Head Start (TCHS) has served over 40,000 children and families in Berrien, Cass, and Van Buren counties.



Family Engagement

At Tri-County Head Start we serve the whole family by supporting, engaging, and educating families. A Family Advocate is assigned to each family to build personal relationships, support them in meeting their needs, and help them identify and achieve goals.

Family Relationships



51% of all families completed the Family Strengths Assessment (FSA). The FSA is a strengths assessment that helps determine a family's strengths and needs.



Of the families that completed an FSA, 86% of them completed a Family Partnership Agreement (FPA). The FPA is an individualized goal-setting process to help support families.



Of the families that completed an FPA, 20% of them were able to accomplish their goal in the 2023-2024 program year.

Kindergarten Readiness

Each year our preschool teachers observe and interview a kindergarten teacher in their community. This helps our teachers understand the expectations and share those with our families and also provides our teachers with the opportunity to share what they do to prepare students and families for the transition to kindergarten.

Kindergarten teachers often say that students need self-help skills to be able to write and recognize their names, count from 1 to 20, and identify some letters. Although our student assessment system does not directly measure these skills, several of the measured indicators closely match, and all are practices embedded in our daily routines.

The data below shows the percentage of preschool students who are at or above their age-level expectations for the most closely matched skills/indicators.

Health and Wellness

Tri-County Head Start helps children and families learn and maintain a healthy lifestyle by supporting healthy families and ensuring children are up-to-date on all immunizations, medical exams, dental exams, and dental treatments. TCHS has a registered dietitian nutritionist who designs our menus and teaches both children and families about nutrition and creating healthy habits. Our Health Services team helps families track upcoming appointments and due dates for immunizations and exams, and our Family Advocates connect families with health providers in our area.

Conscious Discipline

Tri-County Head Start has been invested in supporting Social-Emotional Education for over a decade. In the upcoming school year, TCHS is recommitting to Conscious Discipline.

Conscious Discipline is not something we do; it is something we believe in. It is brain-based, social-emotional learning that builds resilience in students, educators, families, and the community. Conscious Discipline emphasizes bully-proofing interactions in our schools, families, and communities. It supports children's development of accountability and responsibility and helps develop emotionally healthy humans.

"Discipline isn't something you do to children; it is something you develop within them" - Dr. Becky A. Bailey



Conscious Discipline has proven to be transformative, brain-based, and practical. In a major study conducted in 2013, scores from twelve scales were used to compare conscious discipline with non-conscious discipline classrooms drawn from 66 teachers, 1,386 students, and 868 parents at 24 sites in three states over an 8-month period. Results were drawn from teachers, parents of children, and trained classroom observers.

Overall, compared to Non-Conscious Discipline classrooms, the Conscious Discipline classrooms significantly:

- Improved the quality of student/teacher interactions.
- Improved the social and emotional behavior of students.
- Improved the social-emotional behavior of teachers.
- Improved classroom and school climate
- Increased student academic readiness



Tri-County Head Start is funded through a Department of Health and Human Services Head Start award. The Federal grant period and fiscal year for TCHS is February 1 thought January 31. TCHS operates both a Head Start and Early Head Start program, in addition to blended classrooms with the Great Start Readiness Program (GSRP), the state funded preschool program.

Monitoring Results

An annual audit for fiscal year 2022 was conducted by Kruggel Lawton, CPA, and independent auditor, with no findings.

As part of our Federal Grant Award, three monitoring reviews are conducted, results of the most recent reviews are as follows:
